We start off with the sad task of finding a replacement for Ray Slaybaugh, our first selectman. The board accepted his letter of resignation at a special selectboard meeting on January 3, 2023. Ray served our town for over 7 years as board chairman. He served this community well during this time. We all will miss him.

As a result of his resignation, we will be holding a secret ballot election for his replacement on February 21, 2023, during the hours of 2-6 PM. A special town meeting will follow at 6:00 PM to announce our newly elected official. Our regularly scheduled selectboard meeting will follow immediately after. Nomination papers for this position are available in the town office. The newly elected official will serve the remainder of Ray's term, which ends in June 2024.

The budget planning process for fiscal year 2023/2024 will start during the month of February. The budget committee will meet 4 to 5 times over the winter and early spring time frame to complete a proposed budget for the town annual meeting in June. If anyone is interested in serving on this committee, contact our town clerk, Christy Jordan-Rebar, at the town office. Our charter requires that two members of the committee must be from the public at large.

Dogs must be registered by January 31st to avoid late fees.

Vehicle registrations and re-registrations can be done by coming into the town office. You may also register your ATV, UTV, and boat at the office as well as obtain hunting and fishing licenses.

Nomination papers are now available for the position of selectman with a term ending June 2024. Nominations close February 7, 2023. Stop into the town office for a nomination form.

A special town meeting will be held of February 21, 2023 for the purpose of electing a selectman to the board with a term ending June 2024. Voting will be from 2-6 pm with the town meeting immediately following.



Fun Facts!

Osborn was organized as Plantation 21 MD BPP on March 5, 1895. The name was changed to Osborn on April 4, 1923. Osborn was incorporated as a Town on February 11, 1976.

The oldest house in Osborn was built in 1840 and is still standing today!

In 1946-1947 it cost Osborn Plantation a total of \$335.25 for snow removal. This included labor, truck, plowing, sanding, and salt!



On December 14, 2022, the Town of Osborn lost one of its own. Sylvia Sawyer passed away after a brief illness at the age of 95. Sylvia's roots ran deep in Osborn. She most recently served as a member of the Four Town Historical Society where she once served as President and she was a member of the Red Hat Society. She will be missed.
